School-based Interventions

- Early Childhood Centers 10 Contractors
- Elementary Schools 53
- Middle Schools 32
 - 8,689 referral
 - 1,060 needed further support
 - 68 inpatient psychiatry
 - 850 outpatient consults
 - 192 primary care consults
 - □ 151 psychiatry consults
 - □ 350 community programs/services/basic needs
 - □ 33 DPBHS more intense services



Behavioral Health Treatment

- Services to 5,709 children and youth
 - Over 3% increase
- Community-based Services
 - Increase in services provided
 - 5 new services
- Suicide Prevention integrated into services
- DPBHS Mobile Child Priority Response
 - Statewide 1-800-969 HELP (4357)
 - Expanded via federal funds



Moving Forward

House Bill 90, signed 6/8/15

Requires all public school employees to receive 90 minutes of training each year on suicide prevention. LEAs must create suicide prevention policy. All schools must establish suicide prevention committee.


DOE Chairs workshops to implement HB90




Percentage of Middle School Delaware students who seriously thought about killing themselves, 2011 and 2013




Percentage of Middle School Delaware students who seriously thought about killing themselves by Age, 2011 and 2013



Percentage of Middle School Delaware students who seriously thought about killing themselves by Race, 2011 and 2013




Percentage of Middle School Delaware students who seriously thought about killing themselves by Grade, 2011 and 2013
